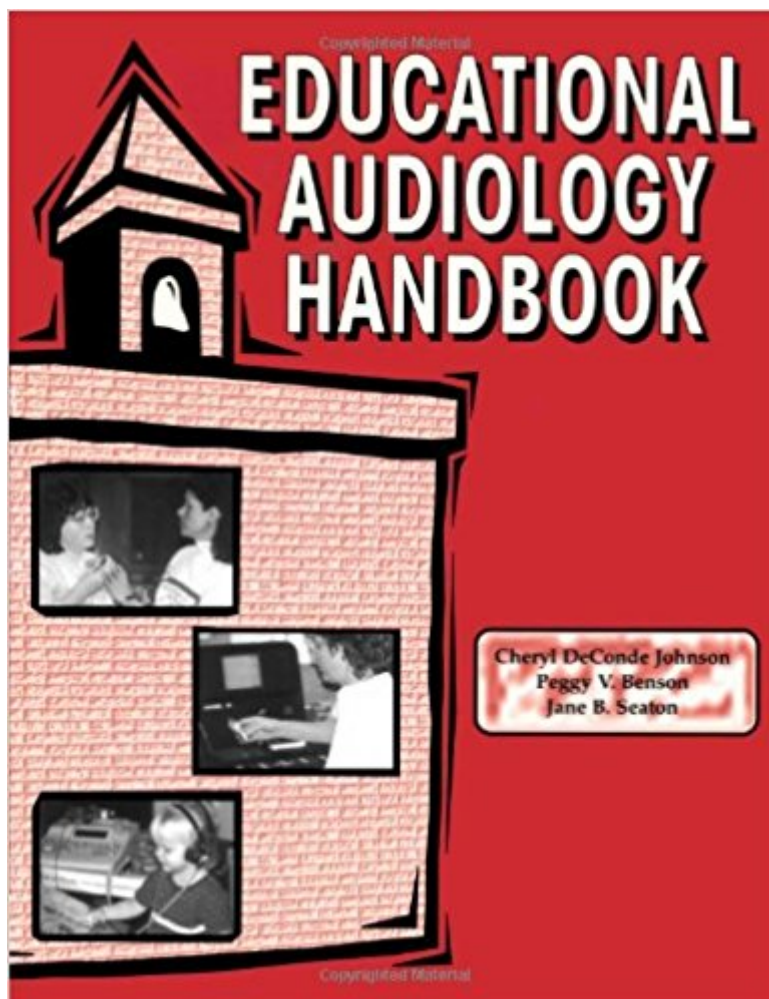

In this position she provided technical assistance and leadership for deaf education, educational interpreting, and educational audiology services statewide. Prior to employment at the Department of Education, Cheryl was an educational audiologist and program coordinator for the deaf and hard of hearing program for 22 years in the Greeley-Evans School District in Greeley, Colorado, and also a regional coordinator for the Colorado Home Intervention Program. At this time, Cheryl maintains an active consulting practice focusing on program evaluation and development, while continuing to pursue various research and writing projects. She conducts trainings in deaf education for the National Association of State Directors of Special Education (NASDSE) as well as individual work with various state education agencies across the US and internationally. She maintains adjunct faculty positions with the University of Colorado, Boulder, the University of Northern Colorado, and the University of Arizona. Cheryl is a co-founder of Hands & Voices and serves as President of the Board of Directors. Her achievements have been recognized by the American Academy of Audiology, American Speech-Language Hearing Association, the University of Northern Colorado, and Phonak (who has established an award in her name). Cheryl has also raised a deaf daughter, now grown, who has provided the joy of two engaging grandsons.

Jane Seaton, M.S., is a private consultant in audiology and communication disorders and has spent more than 40 years working in a variety of settings with families and children who have experienced hearing loss. She developed and administered a model regional educational program for students who are deaf and hard-of-hearing and currently serves as parent advisor, mentor, and consultant for early intervention programs for infants and toddlers with sensory disabilities. An invited faculty member for the ASHA Audiology 2010 Virtual Conference, Jane is presently a stakeholder in the Georgia EHDI program and is working with a project targeting literacy for Georgia students who are deaf and hard of hearing. A recipient of Honors from the Georgia Speech-Language-Hearing Association, she has served on the Georgia Licensure Board for Speech-Language Pathology and Audiology and is a former board member of the American Academy of Audiology and the Educational Audiology Association.

I needed this book for a college class and bought it from since my college bookstore was out. It is a bit dated (and I hear that the new edition will be coming soon), but the material is good. I especially like having the pediatric word lists in the indexes so I can use them for MLV testing right away. I did not buy the supplemental disc because everything on the disc is included in print form in the indexes. This book was "new" and was wrapped in plastic, but the cover had some discolored spots. I just wish I hadn't had to spend this much for a book that is more than a decade out of date, but until it is revised, it's the only one for the subject matter and it's quite good in most areas.

The Educational Audiology Handbook, 2nd Edition offers up to date information about serving children with hearing loss in the schools. Just as the first edition of this book was an absolute "necessity" for Educational and Pediatric Audiologists....the second edition is the Updated Essential for your professional practice library. This book offers comprehensive educational audiology practices and practical tools and handouts. The CD which is included offers documents, forms, and handouts that can be customized and printed for all of your professional needs. This listing is misleading as it reverts back to the 1st edition when you click on "view inside cover and inside contents of the book". It also lists the CD as separate from the book. This was true for the first edition; however, the second edition of this book comes with the CD! A couple of the reviews on are also commenting on the first edition, not the 2nd Edition.

The information displayed regarding the 2nd edition of the Educational Audiology Handbook is misleading. When you order the text you will receive the 2nd edition (June 2011) as well as the accompanying CD of forms, protocols, and other documents. When you click to open the book it currently reverts back to the 1st edition and its contents- you will need to ignore this out-dated

information. The 2nd edition includes 4 additional chapters as well as updated and new appendices. Also, do not order the CD that is listed as it went with the 1st edition and is now out of date. The publisher has asked to correct these issues.
