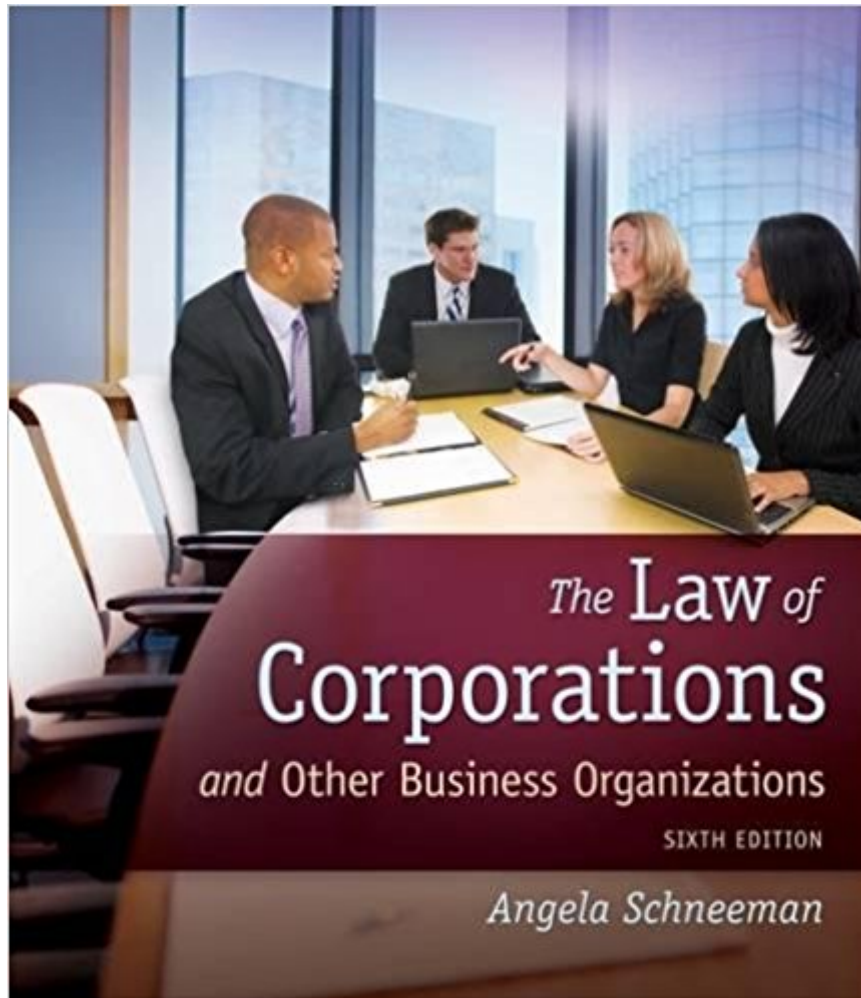

This is a Kindle compatible text book. However, it is not in complete kindle format. What I mean is ,you cannot change the font or paper color, unless you pinch to zoom every page as you go, which is a pain. This is important for older students and professors who need a bit bigger font and a little less stress on the eyes. The creators of these books needs to keep this in mind. It is still better than lugging around a giant text book and a bunch cheaper. I would still buy it but would like the full customization of a true Kindle book.
