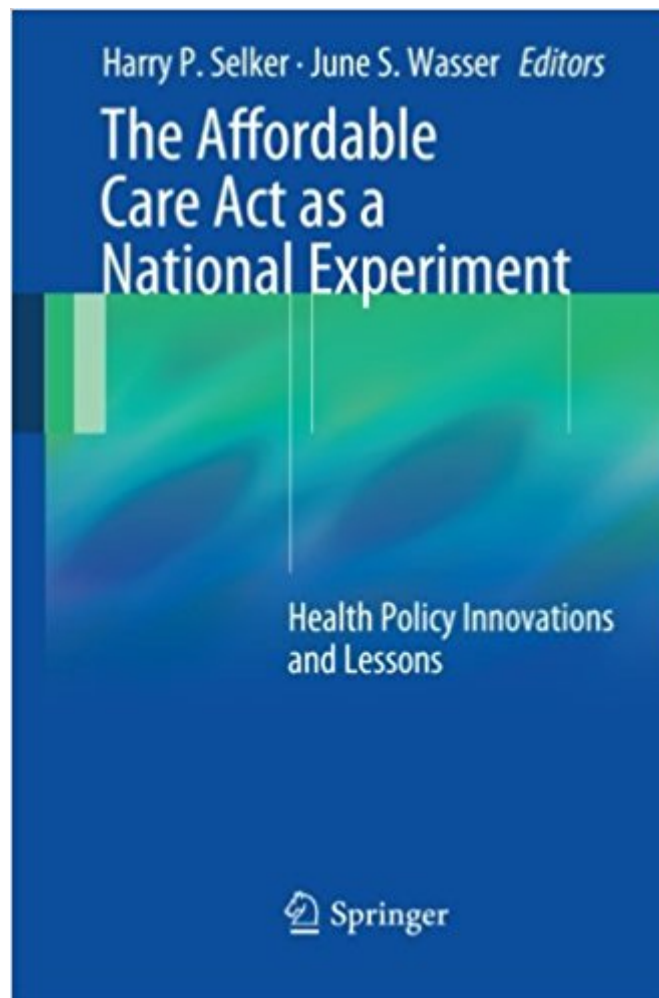

In particular I find that two chapters authored by Dr. Judyann Bigby MD to be of special interest. Dr. Bigby served as Secretary of the Executive Office of Health and Human Services, Commonwealth of Massachusetts from 2007 to 2013. Dr. Bigby is currently director of the Harvard Medical School Center of Excellence in Women’s Health. The authors (all eighteen) describe in some detail how states like Massachusetts and Vermont served as laboratories for principal investigators conducting social experiments in the field of public health. The book is illustrated with many maps and graphs.
